#### 8. LINCOLN UNIVERSITY MOU (VP Murders) – Informational Purposes Only

This month SFCC signed a significant agreement with Lincoln University. The program, Connect Blue, will result in seamless transfer for SFCC students into Lincoln University, streamlined admission processes, and location of an SFCC campus location on the LU campus. Dr. Murders will provide an overview of the Connect Blue program moving forward.

#### 9. HEATING, VENTILATION, AIR CONDITIONING REFRIGERATION & **CONTROLLS TECHNOLOGY (VP Murders)**

It is recommended that the Board of Trustees approve the addition of the Heating, Ventilation, Air Conditioning Refrigeration & Controls Technology program which will offer an Associate in Applied Science and Professional Certificate. Initial funding of equipment is MoExels II Grant funds, and the initial funding for the new faculty is Missouri Apprenticeships in Manufacturing Program (MoAMP).

#### 10. POLICY 1350-PUBLIC ACCESS TO COLLEGE DOCUMENTS (Pres. Bates)

Policy 0510 required Board of Trustees Approval for new or revised policies. It is recommended the Board of Trustees approve a revision to Policy 1350. The revision will allow the board to appoint a Custodian of Records rather than the custodian be tied to a specific college position. The proposed revision has been through institutional review, recommendation, feedback and consensus cycle process as defined in the Internal Communication Plan and as required by Policy 0510.

#### 11. YEATER CHILLED WATER PIPES (VP Acuff)

It is recommended that the Board of Trustees accept the base bid for chilled water piping replacement for the Yeater Learning Center for \$255,887.00 from Pro-Mechanical, LLC of Oak Grove, MO. One other bid was received. It is also recommended that the college not proceed with Alternate 1 of this bid. It is further recommended that the Vice President for Finance and Administration be authorized and directed to sign the Agreement with Pro-Mechanical and perform those acts as necessary to carry out the terms of the Agreement. The funding source is one-time State Deferred Maintenance Funds.

#### 12. CDL SEMI-TRACTOR TRUCKS (VP Acuff)

At the February 23, 2023, the Board of Trustees approved the purchase of two semi-tractor trucks at a price not-to-exceed \$161,00 per truck for the college CDL program. On March 28, 2023, bids were solicited for the trucks and two bids were received. One truck bid from Wisehart Investments of \$155,000.00 has been purchased. The other bid from Jason McGrath is for \$169,500 which exceeds the approval given. It is recommended that the Board of Trustees approve the purchase of one semi-tractor truck for \$169,500.00 from Jason McGrath of Beldenville, WI. Funding is the ARPA Workforce Training Grant.

#### 13. CDL SEMI-TRACTOR TRAILERS (VP Acuff) – Informational Purposes Only

At the February 23, 2023, the Board of Trustees approved the purchase of two trailers for the semi-tractor trucks at a price not-to-exceed \$25,000 each. The college has received a bid for \$11,000.00 each from TransLand of Strafford, MO, for two Wabash trailers. Upon approval by the President, the College will proceed with this purchase. Funding is the ARPA Workforce Training Grant.

#### HEAVY DUTY ROTARY CUTTER BRUSH HOG (VP Acuff) - Informational Purposes 14. **Only**

The College has received a bid for one John Deere RC14R Rotary Cutter for \$16,060.40 from Ag-Power, Inc. of Sedalia, MO. Upon approval by the President, the College will proceed with this purchase. Funding is additional approved FY23 Operating Budget for the Agriculture program.

#### 15. FARM TRACTOR (VP Acuff)

It is recommended that the Board of Trustees accept the bid for one Case IH 110C farm tractor for \$83,400.00 from Crown Power and Equipment. of Lamonte, MO. This bid was selected as the best value bid based on initial cost and local lifespan service costs. Two other bids were received. Funding is additional approved FY23 Operating Budget for the Agriculture program.

### 16. EAB STRATEGIC ADVISORY SERVICES (VP Acuff)

It is recommended that the Board of Trustees approve the 3-year agreement with EAB Global, Inc. of Washington, D.C., in the aggregate amount of \$75,504.35 (paid in 3 annual installments) for Strategic Advisory Services. It is further recommended that the President or Vice President be authorized to sign the agreement with EAB, and that the President be authorized to direct the services to the areas of greatest benefit to the college and its students.
