The Team recently returned from participating in the National Tournament in Las Vegas, bringing back a 2<sup>nd</sup> place trophy for American Skeet and a 2<sup>nd</sup> place in Double Skeet. Coach Manuel was a recognized as the NCSSAA 2022-2023 Division V Coach of the Year. They chose to complete in the NCSSAA this year, which created a higher standard for competition.

PTK Sponsorship & Recognition of Outstanding Student (Kim Miller, Joshua Wyrick)

Kimberly Miller, Math Instructor and Division Chair, gave an overview of the purpose of the Phi Theta Kappa (PTK) and the programs in which they are involved. SFCC's PTK is currently a 4-Star Chapter, but the goal for 2023 is to move up to a 5-Star Chapter.

The All-American Academic Team Scholarships were recently awarded to Lunden Stacey and Joshua Wyrick. Joshua Wyrick was also awarded the New Century Scholars Workforce Pathway Award. In September, he will get to travel to Las Vegas to the ACCT Congress Conference to be recognized for this achievement.

Community Service projects that PTK volunteers in include: Stream Team, Adopt-a-Highway, Bothwell Foundation Lub Dub, CASA Color Run, Sedalia Christmas Parade, Sedalia Noonday Optimist Haunted Hayride, and the Roadrunner Scholastic Tournament.

PTK offers the Edge program which is exclusive for PTK members and gives them a chance to enroll in free courses from five different professional development areas: Research Edge, New Competitive Edge, Transfer Edge, Employment Edge, and Healthcare Edge. SFCC Students Tyler Morey, Bailey Mitchell, and Amber Perez have each completed one or more of these courses.

Recognition of the SFCC eSports Team (Jacob Coleman, eSports Members)
 eSports Rainbow Six Siege Team Members introduced themselves to the Board.

In April, Rainbow Six Siege Team won the National Championship, sponsored by NJCAA. NJCAA has 170 schools, but there are no Divisions, so SFCC was playing against much larger schools.

### • Dental Hygiene Trip to Kenya (Dr. Andra Ferguson)

Dr. Ferguson reported that this summer's trip to Kenya will have them serving at a children's home and women's shelter. She would like to do another report to the Board when they return from Kenya.

It takes \$3,500 per person to make this two-week trip; five will be going. If you would like to sponsor a person going or make a donation, please contact our Dental Hygiene office at (660) 596-7309. They will take cash, checks, or credit cards.

Dental Hygiene student, McKenzie Simpson, spoke about her desire to go to Kenya to be of assistance to the people. She sees this as a great experience since she will be going into Public Health, with a minor in International Studies.

### Retention (Darci McFail, Judi Reine)

Ms. McFail introduced Judi Reine, Tammie Montgomery, Becky Rose, and Shawn Cripe as the Business Intelligence Team, who do the external reporting, fulfilling internal data requests, and setting up dashboards. Ms. Reine reported that they have been working on different ways to report retention. The several ways they can report this is Fall-to-Spring, Fall-to-Fall, and within the semester. They divide the groups of students in degree-seeking and non-degree-seeking (dual credit, visiting students, special interest). The Fall-to-Fall report that we report to the government showed that the National Overall Average was 61%, while our Overall Average is 64%. Our within the semester retention rate is good – ranges from 94.6% to 96.7% for degree-seeking. The non-degree-seeking rate is even better. The Deans analyze these retention numbers and strategize on ways to make additional improvements.

#### LINCOLN UNIVERSITY MOU – Informational Purposes Only

On April 18<sup>th</sup> SFCC signed a significant agreement with Lincoln University. Dr. Murders reported that the program, Connect Blue, will result in seamless transfer for SFCC students into Lincoln University, streamline admission processes, and will allow SFCC to have a location on the LU campus in Jefferson City. Many from SFCC will be involved in the startup for this new location.

## HEATING, VENTILATION, AIR CONDITIONING REFRIGERATION & CONTROLS TECHNOLOGY

Dr. Breshears moved the Board of Trustees approve the addition of the Heating, Ventilation, Air Conditioning Refrigeration & Controls Technology program which will offer an Associate in Applied Science and Professional Certificate. Mr. Oldham seconded the motion; motion carried (Yes-6; No-0).

Initial funding of equipment is MoExels II Grant funds, and the initial funding for the new faculty is Missouri Apprenticeships in Manufacturing Program (MoAMP).

#### POLICY 1350-PUBLIC ACCESS TO COLLEGE DOCUMENTS

Mr. Oldham moved the Board of Trustees approve a revision to Policy 1350. The revision will allow the board to appoint a Custodian of Records rather than the custodian be tied to a specific college position. Mr. Carr seconded the motion; motion carried (Yes-6; No-0).

The proposed revision has been through institutional review, recommendation, feedback and consensus cycle process as defined in the Internal Communication Plan and as required by Policy 0510.

#### YEATER CHILLED WATER PIPES

Mr. Oldham moved the Board of Trustees accept the base bid for chilled water piping replacement for the Yeater Learning Center for \$255,887.00 from Pro-Mechanical, LLC of Oak Grove, MO. It is also recommended that the college not proceed with Alternate 1 of this bid. It is further recommended that the Vice President for Finance and Administration be authorized and directed to sign the Agreement with Pro-Mechanical and perform those acts as necessary to carry out the terms of the Agreement. Mr. Parker seconded the motion; motion carried (Yes-6; No-0).

The funding source is one-time State Deferred Maintenance Funds.

#### CDL SEMI-TRACTOR TRUCKS

Mr. Carr moved the Board of Trustees approve the purchase of one semi-tractor truck for \$169,500.00 from Jason McGrath of Beldenville, WI. Mr. Oldham seconded the motion; motion carried (Yes-6; No-0).

At the February 23, 2023, the Board of Trustees approved the purchase of two semi-tractor trucks at a price not-to-exceed \$161,00 per truck for the college CDL program. On March 28, 2023, bids were solicited for the trucks and two bids were received. One truck bid from Wisehart Investments of \$155,000.00 has been purchased. Funding is the ARPA Workforce Training Grant.

#### CDL SEMI-TRACTOR TRAILERS – Informational Purposes Only

At the February 23, 2023, the Board of Trustees approved the purchase of two trailers for the semi-tractor trucks at a price not-to-exceed \$25,000 each. The college has received a bid for \$11,000.00 each from TransLand of Strafford, MO, for two Wabash trailers. Upon approval by the President, the College will proceed with this purchase. Funding is the ARPA Workforce Training Grant.

#### HEAVY DUTY ROTARY CUTTER BRUSH HOG – Informational Purposes Only

The College has received a bid for one John Deere RC14R Rotary Cutter for \$16,060.40 from Ag-Power, Inc. of Sedalia, MO. Upon approval by the President, the College will proceed with this purchase. Funding is additional approved FY23 Operating Budget for the Agriculture program.

#### FARM TRACTOR

Mr. Oldham moved the Board of Trustees accept the bid for one Case IH 110C farm tractor for \$83,400.00 from Crown Power and Equipment. of Lamonte, MO. Mr. Carr seconded the motion; motion carried (Yes-6; No-0).

Funding is additional approved FY23 Operating Budget for the Agriculture program.

#### EAB STRATEGIC ADVISORY SERVICES

Mr. Parker moved the Board of Trustees approve the 3-year agreement with EAB Global, Inc. of Washington, D.C., in the aggregate amount of \$75,504.35 (paid in 3 annual installments) for Strategic Advisory Services and that the President or Vice President be authorized to sign the agreement with EAB, and that the President be authorized to direct the services to the areas of greatest benefit to the college and its students. Dr. Breshears seconded the motion; motion carried (Yes-6; No-0).

Funding is through the Annual Operating Budget.

#### OHWIC COMPRESSOR ROOM VENTILATION

Mr. Oldham moved the Board of Trustees approve the bid from Haulotte Construction Services of Sedalia, MO, in the amount of \$33,268.00 for repair of the ventilation/temperature control system in the OHWIC Compressor/Water Service room, and that the Vice President for Finance and Administration be authorized and directed to sign the Agreement with Haulotte Construction Services and perform those acts as necessary to carry out the terms of the Agreement. Mr. Parker seconded the motion; motion carried (Yes-6; No-0).

Funding is FY2023 Maintenance & Repair funds.

#### ENGINEERING DESIGN TECHNOLOGY LIDAR SCANNER

Mr. Carr moved the Board of Trustees approve the single source bid from Seiler Geospatial of Lenexa, KS, in the amount of \$43,119.00 for one Trimble X7 LiDAR Scanner Kit system including training. Mr. Oldham seconded the motion; motion passed (Yes-6; No-0).

This system will be used by the Engineering Design Technology program. Funding is Perkins V CTE Grants.

#### PRESIDENT'S REPORT (Pres. Bates)

- Dr. Bates asked the Board of Trustees to let Lisa know which graduation ceremonies they will be able to attend.
- Dr. Bates announced that Board Member Patricia Wood has been named as the Distinguished Alumni. A reception will be held in her honor on May 19<sup>th</sup> at 3:30 p.m. in the Daum Lobby.
