#### INSTITUTIONAL REPORT

A copy of the Athletics Strategic Plan was included in the Board of Trustees' agenda packet. Darren Pannier, Athletic Director, recognized Intern Lane McFail who played a big part in helping with the document, and discussed in more detail the strategic priorities as stated in the document. Additionally, Darren recognized the sports teams that received the NJCAA Academic Team Awards for having a team GPA of 3.0 or above. The teams honored were Men's Cross Country, Women's Basketball, Baseball, and Softball.

# SEDALIA CAMPUS ELECTRONIC SIGN STATUS REPORT (Facilities Director, O'Neal/Marketing Director, Henderson)

Due to continuing technical issues on the digital portion of the college sign at 16<sup>th</sup> and Clarendon, maintenance will be removing the digital board from the marquis. This will leave the brick base with the SFCC logo. Mr. Henderson will be researching options for future recommendation. Currently we have an agreement with the MO State Fairgrounds to place our messaging on their digital sign on Limit Avenue.

### SUPPLEMENTAL SUPPORT UNDER THE AMERICAN RESCUE PLAN (VP, Acuff)

In March 2022, The Department of Education announced the availability of \$198 million in additional grants with the Supplemental Support under the American Rescue Plan (SSARP) grants. These grants required application from colleges and universities to receive the grants. State Fair Community College applied for additional funding under these grants and has been awarded \$950,133 from the SSARP. 50% of these funds are designated for direct student grants to be used for any element of a student's cost of attendance including tuition, fees and required course materials. They may also be used for the retention and reengagement of students, or for emergency costs relating to the COVID-19 pandemic including housing costs, food costs, or health care, or childcare expenses. The remaining funds are institutional funds which must be used under the existing guidance outlined in the American Rescue Plan.

Mr. Oldham moved the Board of Trustees authorize the President to accept the SSARP grant funds in the amount of \$950,133 and to authorize the President and the Vice President, Finance and Administration to disburse SSARP student grant funds and institutional funds in accordance with the provisions of the American Rescue Plan Act of 2021. Dr. Breshears seconded the motion – motion carried. (Yes 6; No 0)

# ADDITIONAL FUNDS TO PURCHASE PROPERTY WEST OF SFCC CAMPUS (VP, Acuff)

Mr. Oldham moved the Board of Trustees to approve an additional \$1,000,000 from State Fair Community College reserve funds for the purchase of approximately 200 acres of land to the west of, and adjacent to, the current SFCC property boundary. Mr. Hubbs seconded the motion – motion carried. (Yes 6; No 0)

# COMMERCIAL INSURANCE COVERAGES (VP, Acuff)

Mr. Carr moved the Board of Trustees approve the commercial insurance renewal premium payment to Assured Partners of Sedalia, MO in the amount of \$415,783 for FY2023. This is no change from prior year and has been accounted for in the FY23 budget. Mr. Oldham seconded the motion – motion carried. (Yes 6; No 0)

# ATHLETIC INSURANCE COVERAGE (VP, Acuff)

Mr. Oldham moved the Board of Trustees approve the athletic insurance renewal premium payment to Arthur J. Gallagher, First Agency Branch of Kalamazoo, MI in the amount of \$46,916 for FY2023. This is no change from the prior year and has been accounted for in the FY23 budget. Dr. Breshears seconded the motion – motion carried. (Yes 6; No 0)

# PHAB LAB DESIGN, EQUIPMENT & SUPPLIES (VP, Acuff)

Mr. Oldham moved the Board of Trustees accept the sole source purchase of design services, equipment and supplies for the Advanced Manufacturing Phab Lab from Palmer Hamilton of Elkhorn, WI in the amount of \$125,102.10. This purchase is in support of the NSF grant awarded to State Fair Community College. Funding is 54% (\$67,524) NSF grant, 31.2% (\$39,040) MoAmp grant, 9.4% (\$11,736) J. Higdon Potter Foundation and 5.4% (\$6,802) SFCC Operating Budget. Mr. Parker seconded the motion – motion carried. (Yes 6; No 0)

# COMMERCIAL DRIVING ACADEMY SIMULATOR (VP, Acuff)

Mr. Oldham moved the Board of Trustees accept the bid for a CDA truck driving simulator from Virage Simulation, Inc of Montreal, Quebec, Canada in the amount of \$149,500. These are items A-E & G in the bid. The simulator will be utilized to support SFCC's CDL training and provide the CDA program with state-of-the-art training equipment to meet the increased demand. Funding is from one-time State of Missouri FY23 Community College Funding. Mr. Hubbs seconded the motion – motion carried. (Yes 6; No 0)

# OHWIC COLLABORATIVE WELDING SYSTEM (VP, Acuff)

Mr. Hubbs moved the Board of Trustees accept the bid for 2 Coper Cart Collaborative Welding Systems from Linde Gas & Equipment of Sedalia, MO in the amount of \$174,900. This equipment will further equip the OHWIC to be a leading provider of training for our students and our industry partners and would be funded under the MoExcels II grant. Mr. Oldham seconded the motion – motion carried. (Yes 6; No 0)
