

# What is State Fair Community College's policy on incentive, bonuses, or commission payments and high-pressure recruitment activities?

(Question 1 and 2 on DoD Voluntary Education MOU Institutional Compliance Program: Self-Assessment)

State Fair Community College has established a philosophy that ensures the institution refrains from providing commissions, bonuses, or other incentive payments based directly or indirectly on securing enrollments or federal financial aid (including military Tuition Assistance funds) to any persons or entities engaged in any student recruiting, admission activities, or making decisions regarding the award of student financial assistance.

Below is an excerpt from our employee handbook, paragraphs 1 and 2 details the ban on incentive type payments for securing enrollment. Paragraph 3 explains the ban on high-pressure recruitment activities.

## State Fair Community College Philosophy

As part of State Fair Community College's efforts to ensure that unfair, deceptive, and abusive marketing initiatives are not part of our culture, policies, or procedures SFCC will:

1. Ban inducements, including any gratuity, favor, discount, entertainment, hospitality, loan, transportation, lodging, meals, or other item having a monetary value of more than a *de minimis* [defined as "an insignificant amount"] to any individual or entity, or its agents including third party lead generators or marketing firms other than salaries paid to employees or fees paid to contractors in conformity with all applicable laws for the purpose of securing enrollments of military service members or obtaining access to military tuition assistance funds, SFCC sponsored scholarships or grants and tuition reductions available to military students are permissible;
2. Refrain from providing any commission, bonus, or other incentive payment based directly or indirectly on securing enrollments or federal financial aid (including military tuition assistance funds) to any persons or entities engaged in any student recruiting, admission activities, or making decisions regarding the award of student financial assistance;
3. Refrain from high-pressure recruitment tactics such as making multiple unsolicited contacts (3 or more), including contacts by phone, email, or in-person, and engaging in same-day recruitment and registration for the purpose of securing military service member enrollments.

## Whom should a military service member talk to about Military Tuition Assistance?

(Question 3 on DoD Voluntary Education MOU Institutional Compliance Program: Self-Assessment)

State Fair Community College has standard practices and procedures in place to direct military service members receive approval from their Educational Services Officer (ESO), and/or education counselor within their Military Service prior to enrolling the military service member in classes at our institution.

## **Does State Fair Community College have a trained and qualified financial aid advisor who will make available appropriate student loan counseling information?** (Question 4 on DoD Voluntary Education MOU Institutional Compliance Program: Self-Assessment)

As per SFCC's Policy 2710, the College has designated our Financial Aid and Veteran Services Office Director as the administrator who will ensure the financial aid advisor/loan counselors in that office are trained and qualified prior to providing student loan other financial aid program information.

### **Title IV Administrator Designation Policy 2710**

The Board of Trustees authorizes the College to participate in and maintain eligibility in federal financial aid programs as approved by applicable governing agencies. The College shall designate an administrator to assure compliance with Title IV of the Higher Education Act of 1965, as amended. Students are required to complete the Free Application for Federal Student Aid (FAFSA) form to be considered for any federal financial aid. The Office of Financial Aid and Veteran Services will maintain accurate records, complete appropriate filing with federal agencies in a timely fashion and distribute funds to eligible students.

## **Where can a military service member find information on Financial Aid?** (Question 5 on DoD Voluntary Education MOU Institutional Compliance Program: Self-Assessment)

All State Fair Community College students, to include military service members, veterans, and their families are informed about their options to help pay for their college education early, and often, in the admission and enrollment processes. - Academic Year 2018-2019 – 15.8% - 939 students accepted loans out of about 5,943 total students

## How does State Fair Community College's CDR compare to the national average? (Question 6C on DoD Voluntary Education MOU Institutional Compliance Program: Self-Assessment)

**State Fair Community College’s 2017 CDR is 17.1% and the national average is 9.7% for all colleges and universities.**

SFCC FY2017 average loan default rate is 17.1% of student borrowers who entered into loan repayment and had defaulted within three years (compared to the nation average of both 2 yr. and 4 yr. institutions of 9.7%). Annually, as part of the Financial Aid New Year setup the new loan default rate is updated in our computer system, web site, and any applicable documents/publications.

**What is State Fair Community College’s Return of Military Tuition Assistance funds policy?** (Question 7 on DoD Voluntary Education MOU Institutional Compliance Program: Self-Assessment)

State Fair Community College returns any unearned military tuition assistance funds to the applicable Service based on our **Return of Military Tuition Assistance Policy**. In simple terms, our policy is based on the longer a student stays in class the more funds they earn and our process complies with Department of Education and Department of Defense return of funds guidance for this program.

## **SFCC Return of Military Tuition Assistance Policy 3360 excerpt:**

### Return of Military Tuition Assistance Funds

State Fair Community College (SFCC) will adhere to Department of Defense Return of Military Tuition Assistance (TA) funds guidance when a qualifying student drops a class as set forth in Regulation 3362.

## **SFCC Return of Military Tuition Assistance Regulation 3362 is:**

State Fair Community College will adhere to DoD Return of Military Tuition Assistance funds guidance when a military service member drops a class.

The College will return any military tuition assistance program funds directly to the applicable military service and not to the military service member.

1. The College will return all (100 percent) of military assistance funds to the applicable military service when the military service member drops a class they are enrolled in up to the end of the College's 100 percent refund period for the applicable part-of-term. This includes when a student does not inform the College they do not plan to attend the class, to include if they do start attendance in other courses.
2. The College will return any military tuition assistance funds paid for a course that is cancelled by the College.
3. The College will return any unearned military tuition assistance funds on a proportional basis through the 60 percent portion of the period for which the funds were provided as determined by the class' part-of-term start and end dates. Military tuition assistance funds are considered earned proportionally during an enrollment period, with unearned funds returned based upon when a student drops the course.
4. When a military service member stops attending due to a military service obligation, the College will work with the affected Service member through the Military Withdrawal process to determine solutions that will not result in a student debt for the returned portion.

The College will return unearned military tuition assistance funds proportionally based on the below schedule. For any classes not 16-weeks or 8-weeks in length, the same percentages (100%, 50%, & 60% points in the course) will be used for that part-of-term.

### **For example:**

#### **16-week classes –**

- **Refund Point 1** – Student drops a class during the *First 5 days* (First week) of the class: 100% refund of tuition and fee charges given for dropped class. 100% of associated military tuition assistance funds returned to applicable Service.



- **Refund Point 2** - Student drops a class during *Weeks 2 – 8*: No refund of tuition and fee charges given for dropped class. 50% of associated military tuition assistance funds returned to applicable Service.
- **Refund Point 3** - Student drops a class during *Weeks 9 & 10* (60% point) of the semester: No refund of tuition and fee charges given for dropped class. 40% of associated military tuition assistance funds returned to applicable Service.
- Student drops a class *After week 10* - No refund of tuition and fee charges given for dropped class. No military tuition assistance funds returned to applicable Service.

#### 8-week classes –

- **Refund Point 1** - Student drops a class during the *First 5 days* of the class: 100% refund of tuition and fee charges for dropped class. 100% of associated military tuition assistance funds returned to applicable Service.
- **Refund Point 2** - Student drops a class during *Weeks 2 – 4*: No refund of tuition and fee charges given for dropped class. 50% of associated military tuition assistance funds returned to applicable Service.
- **Refund Point 3** - Student drops a class during *Week 5* (60% point) of the semester: No refund of tuition and fee charges given for dropped class. 40% of associated military tuition assistance funds returned to applicable Service.
- Student drops a class *After week 5* - No refund of tuition and fee charges given for dropped class. No military tuition assistance funds returned to applicable Service.

Note: Military service members are reminded that if the drop was due to their military responsibilities they are encouraged to submit a Military Withdrawal Form and may qualify for a 100% refund of tuition and fees. If request is approved then all associated tuition and fee charges would be refunded and the military tuition assistance funds for that class would be returned to the applicable Service.

**Degree Program Statute of Limitations** - The college catalog is effective in the fall semester. A student may use for degree requirements the catalog in effect at the time of initial enrollment or any subsequent catalog provided:

1. The catalog is dated no more than six years to the date the degree is to be conferred;
2. The student enrolled in classes and earned academic credit during the time the chosen catalog was in effect;
3. Only one catalog is used to determine curriculum. (To use a subsequent catalog a student must submit a change of program/catalog request.)

Students who do not earn academic credit for four consecutive regular semesters (excluding summer) may only use the catalog in effect from the time of their re-entry. A student may not continue in the original program of study if the program was discontinued in the original program of study if the program was discontinued prior to re-entry. (Taken from Regulation 2511)

**Credit for armed service experience** Advanced placement credit may be granted for educational training earned while in the armed services, according to the American Council of Education (ACE) recommendations. The credit must be appropriate to the degree sought. Students must submit a military transcript to be evaluated for college credit. In some cases (e.g. the course (s) were taken many years ago), a military transcript may not be available. Students will need to contact the Academic Records and Registrar office to determine what other documents are acceptable to be evaluated for college credit. Students will receive two physical activity credits upon submission of a DD-214. These credits do not count toward the wellness requirement.

This applies to any student who cannot attend school due to military service. Military service includes service by a member of the National Guard or Reserve.

Below is an excerpt of Policy 2180 and Regulation 2180 that covers readmission of military.

Policy 2180

Nondiscrimination and Student Rights

State Fair Community College will establish a process regarding compliance with Department of Defense, Veteran Affairs, and Department of Education Title IV guidelines, as well as consistency with Missouri Revised Statute, Chapter 41. The College shall designate an administrator(s) to assure compliance with the aforementioned agencies.

Within Regulation 2180, the section entitled READMISSION specifically covers this situation.

#### READMISSION:

Per guidance 34 CFR 668.18, the college will promptly readmit a qualifying student into the next class or classes in the program beginning after they provide notice of intent to reenroll. The college will readmit the student with the same academic status, which means;

- To the same program to which the student was last admitted or if that exact program is no longer offered, the program that is most similar to that program
- With the same number of credit hours previously completed at SFCC, and
- With the same academic standing (i.e. With the same satisfactory academic progress status) the student previously had.

If the student chooses a different program the credit hours will be reviewed to determine if the credits are transferrable to the new program.

If the student is readmitted to the same program, for the first academic year in which they return, the school must assess the tuition and fee charges that they would have been assessed for the academic year during which they left the school. However, if their veteran education benefits or other service member education benefits will pay the higher tuition and fee charges the other students in the program are paying for the year, the school may assess those charges to the student as well.

If a student is readmitted to a different program, and for subsequent academic years for a student admitted to the same program, the school must assess no more than the tuition and fee charges that other students in the program are assessed for the academic year.

This process, in many cases, may provide the best options for students who had to stop attending college due to their military service obligations.
