Step One: Meet State Fair Community Conege (SFCC) Admission Frocedures
Submit an online SFCC Application for Admission at <a href="www.sfccmo.edu/admissions">www.sfccmo.edu/admissions</a> . Students must be <b>fully admitted (Enrollment Checklist completed)</b> to SFCC with all official transcripts <b>received and articulated</b> before April 1. Students must submit official college transcripts from all colleges where credit was earned or attempted, including dual credit earned in High School.
Step Two: Meet SFCC Behavioral Health Support Program Admission Requirements

☐ Complete all prerequisite by the end of the Spring semester in which the student is applying with the minimum grade requirements.

Students in the Behavioral Health Support program are admitted to the college on the same basis as other students, but admission to the college does not ensure admission into the Behavioral Health Support program.

All applicants will be notified of their status **via SFCC student email**. All attempts will be made to have notifications out by the first week of June. Please do not contact the program or Navigator to request your status prior to the second week of June. Please be sure you have a current address, email, and phone number in the mySFCC system on the Academics tab under "personal information". We cannot offer admission to all the qualified applicants. Our enrollment is limited to 25. Only students meeting the minimum requirements will be presented to the Admissions Committee. The following information may be evaluated during the selection process: Oral communication skills, written communication skills, professionalism, critical thinking ability, motivation for the profession, commitment to completing the program, career and professional goals, and realistic expectations.

The information above is directly related to the Behavioral Health Support program mission, vision and goals. Every effort is made to ensure the selection process is fair and equitable to all applicants. The selection process strives to achieve a well-rounded assessment of the student as a whole.

#### **Essay Instructions**

#### Please use the following instructions as you prepare your admission essay:

Submit a 2-page typed essay with your name and SFCC student ID# in the top left-hand corner. The Essay should be double spaced, use 12- point Times New Roman font, and have 1-inch margins. The essay should utilize correct grammar, punctuation, and spelling.

### The essay should include, but is not limited to, the following 3 topics:

- 1. What motivated you to pursue a career in Behavioral Health? What personal experiences led you to this decision (if any)? In what ways will working in behavioral health benefit you?
- 2. What is your strategy for successfully completing a rigorous full-time program? Some components of success include managing personal and family challenges, time management, school/work balance, successful completion of practicum, transportation, and financial commitments.
- 3. What are your career/professional goals post-graduation?

The essay is an important component of the application process as many of the program classes include written assignments; therefore, strong writing and communication skills are vital. Communication is extremely important for behavioral health professionals because one must be able to communicate with clients as well as other members of the therapeutic team. Applicants are encouraged to utilize the Academic Success Center. Students may send their papers to the tutors via email. Tutors may not be able to help with your professional related wording, but they will be able to help with writing mechanics, such as critical thinking, organization, and professionalism, sentence structure, grammar, spelling, and clarity.





### **Post-Application Program Admission Checklist**

Satisfactory background check – Students must have a satisfactory background check utilizing a United States Social Security number. Background check is completed after admission to program. Any applicant who has been convicted of felonies and/or misdemeanors must discuss this matter with the Behavioral Health Support Program Coordinator.
Drug screening- Drug testing is completed after admission to program. Refer to policy included in the Behavioral Health Support Information Packet.
Completion of immunization requirements- Occurs after admission to program. Refer to policy included in the Behavioral Health Support Information Packet.
Program orientation- Occurs after admission to program. Details will be sent to students via SFCC student email.

Final decision of admission to the program will occur when the above criteria have been met and completed and reviewed by the Behavioral Health Admissions Committee.
