



## Aggregate Loan/Pell Limits (LLIMIT) or (NOPELL)

Since you are nearing your lifetime loan limit and/or Pell Grant, we wanted you to be aware of how much aid you have left to complete your degree.

### Stafford Loan

Combined overall subsidized and unsubsidized outstanding debt limits are as follows:

Aggregate Loan Limits for Dependent Undergraduate	Aggregate Loan Limits for Independent Undergraduate
\$31,000, No more than \$23,000 of this amount may be in the form of subsidized loans. (\$57,500 for a dependent undergraduate student whose parents/contributors do not qualify for PLUS loans.)	\$57,500, No more than \$23,000 of this amount may be in the form of subsidized loans.

### Pell Grant

The amount of *Federal Pell Grant* funds you may receive over your lifetime is the equivalent of six years or 600%. The maximum amount of Pell Grant funding you can receive each year is equal to 150%.
