### A. Passenger Vehicles – Qty. 4

- CAN-NOT be hybrid or electric
- Must be a gasoline vehicle
- Flex Fuel ok
- Any cylinder
- Must have title with no liens
- MUST be able to start and drive
- Salvage Vehicles ok

### B. Diesel Pickup Trucks – Qty. 2

- Must be 10 years or newer
- Should have reasonable tire tread remaining
- Can be any make and model
- Must be 4-wheel drive
- Must have ORIGINAL factory mechanical and exhaust equipment
